COUNT 1

R.S. 14:26/64 and 14:64.3 - CONSPIRACY TO COMMIT ARMED ROBBERY WITH A FIREARM

JASON DAVID LANDRY AND BRITTNEY MICHELLE SAVELL AND DERRION JOSEPH LEMOINE, on or about February 15, 2018, by conspiring to commit armed robbery with a firearm by the taking of anything of value belonging to another from the person or in the immediate control of Reagan Elizabeth Day by use of force or intimidation while armed with a dangerous weapon, to-wit: A Gun, and that said weapon was a firearm under the provisions of R.S. 14:64.3.

COUNT 2

R.S. 14:26/64 and 14:64.3 - CONSPIRACY TO COMMIT ARMED ROBBERY WITH A FIREARM

JASON DAVID LANDRY AND BRITTNEY MICHELLE SAVELL AND DERRION JOSEPH LEMOINE, on or about February 15, 2018, by conspiring to commit armed robbery with a firearm by the taking of anything of value

COUNT 3

R.S. 14:44 - AGGRAVATED KIDNAPPING

JASON DAVID LANDRY AND BRITTNEY MICHELLE SAVELL AND DERRION JOSEPH LEMOINE, on or about February 15, 2018, by committing aggravated kidnapping of Reagan Elizabeth Day.

COUNT 4

R.S. 14:44 - AGGRAVATED KIDNAPPING

JASON DAVID LANDRY AND BRITTNEY MICHELLE SAVELL AND DERRION JOSEPH LEMOINE, on or about February 15, 2018, by committing aggravated kidnapping of Dustin Ross Hartline.

COUNT 5

R.S. 14:30 - FIRST DEGREE MURDER

JASON DAVID LANDRY, on or about February 15, 2018, committed first degree murder of Dustin Ross Hartline.

COUNT 6

R.S. 14:30 - FIRST DEGREE MURDER

JASON DAVID LANDRY AND STEVEN LEE OLIVIERI, on or about February 15, 2018, committed first degree murder of Reagan Elizabeth Day.

COUNT 7

R.S. 14:30.1 - SECOND DEGREE MURDER

BRITTNEY MICHELLE SAVELL AND DERRION JOSEPH LEMOINE, on or about February 15, 2018, committed second degree murder of Dustin Ross Hartline.

COUNT 8

R.S. 14:30.1 - SECOND DEGREE MURDER

BRITTNEY MICHELLE SAVELL AND DERRION JOSEPH LEMOINE, on or about February 15, 2018, committed second degree murder of Reagan Elizabeth Day.

COUNT 9

R.S. 14:130.1.A(1)B(1) - OBSTRUCTION OF JUSTICE BY TAMPERING WITH EVIDENCE

STEVEN LEE OLIVIERI AND DERRION JOSEPH LEMOINE, on or between February 15, 2018 and February 16, 2018, by tampering with evidence with the specific intent of distorting the results of any criminal investigation or proceeding which may reasonably prove relevant to a criminal investigation or proceeding, when it involves a criminal proceeding in which a sentence of death or life imprisonment may be imposed.

COUNT 10

R.S. 14:95.1 - POSSESSION OF FIREARM OR CARRYING A CONCEALED WEAPON BY A PERSON CONVICTED OF A FELONY

DERRION JOSEPH LEMOINE, on or about February 15, 2018, by having previously been convicted of Simple Burglary, Attempted Simple Burglary and Simple Criminal Damage to Property on October 7, 2015 under Docket Number 505550, in the 22nd Judicial District Court in St. Tammany Parish, and possessing

R.S. 14:95.1 - POSSESSION OF FIREARM OR CARRYING A CONCEALED WEAPON BY A PERSON CONVICTED OF A FELONY

STEVEN LEE OLIVIERI, on or about February 15, 2018, by having previously been convicted of Armed Robbery on June 18, 2010 under Docket Number 095166, in the 24th Judicial District Court in Jefferson Parish, and possessing a firearm or carrying a concealed weapon, to-wit: A Gun.

R.S. 14:25 - ACCESSORY AFTER THE FACT




